## **Admission Agreement**

Thank You for choosing **MORNINGSTAR LEARNING CENTER** (Morningstar) for the development and care of your child(ren). We pledge to serve your child(ren) with the utmost care available.

Our program is licensed for children in grades Kindergarten through  $5^{th}$  Grade. Morningstar's operating hours are Mondays through Fridays, 12:00 p.m. to 6:30 p.m. when regular school is in session.

- 1. **Payment of Fees** All fees for Morningstar (basic fees and optional class fee) will be paid by the parent / guardian on the date shown on the invoice. Fees are paid in the form of check made payable to "Morningstar Educational Group Inc." A late fee of \$20.00 will be charged if payment is not received by 6:30 p.m. on the due day. Any late fees and other extra charges will be reflected on the invoice for the next period. Your current payment for Morningstar is \_\_\_\_\_\_ every four weeks.
- 2. **Registration/Enrollment**-A non-refundable registration fee of \$100.00 is due at the time your child(ren) is enrolled in **Morningstar**. A deposit of \$250 is due at the same time. All Morningstar required forms must be completely filled prior to your child(ren)'s attendance. Falsification of any required documentation may result in immediate termination of service.

- 3. **Termination (Withdrawal)** --A 4-week written notice in advance is required prior to your child(ren) leaving Morningstar. If you provide a 4-week written notice before terminating the program, the deposit will be refunded on your child(ren)'s last day with Morningstar. If you do not provide a 4-week written notice before terminating the program, your deposit will be forfeited. Please note that the deposit does not substitute as tuition, and that you are still responsible for your child(ren)'s last 4 weeks of payment at Morningstar. This 4-week written notice requirement also applies to all child(ren) who do not plan to attend the first day of the Fall Program, usually starting in mid-August.
- 4. **Sign In/ Sign out**--All children will be signed in and out daily and the sign-in/out sheet must be filled in clearly and in complete detail (signature, not initials) by parents or guardians. All consequences thereafter shall be the parent or guardian's responsibility for not signing in or signing out the child(ren).
- 5. **Holidays –Morningstar** observes the major Holidays and will be closed during the following Holidays: Presidents' Day, Memorial Day, Independence Day, Labor Day and Thanksgiving Day. We will also be closed for two weeks for Christmas and New Years.
- 6. **Tuition Refund Policy for Hiatus --** The tuition covered for child(ren)who miss less than 9 contiguous days of school will not be refunded. The tuition covered for child(ren) who miss 10 contiguous days or more will be eligible for refunds up to half of the days missed. Tuition will not be charged for absence of 4 weeks or more, but the 4-week written notice is required AND the child(ren) will have to be re-registered upon return and a new registration fee will be charged.
- 7. **Extracurricular Activities Fee** –Morningstar provides many extracurricular activities that require an extra fee. There will be no refunds for any unattended extracurricular classes. There will be make up classes if the teacher is absent or if Morningstar fails to provide the class.
- 8. **Daycare** Daycare will be provided for Spring Break, Teacher's learning Day, etc. The daycare fee will be charged is \$30.00 from 8:30 a.m.-12:00p.m., \$45.00 from 8:30-2:30p.m., \$20.00 from 12:00 p.m.-2:30 p.m. For Winter Break, the daycare fee is \$70 from 8:30a.m. until 6:30p.m. **F**ailure to sign-up in advance will result in an extra \$10 for drop-in on the day of. Lunch will be provided upon request Morningstar prepared lunches is \$6.00 per meal.
- 9. **Leaving the Premises** Any child(ren) leaving Morningstar's premises must be accompanied by an authorized adult listed on the emergency card.
- 10. **Late Child Pick-up Penalty -** A penalty fee of \$1.00 per 1 minute overtime (after 6:30p.m.) will be charged. Late fees shall be paid in **cash** directly to the accompanying teacher.
- 11. **Transportation-** Morningstar does NOT provide any transportation servise.
  - **NOTE:** Any child(ren) transportation is a contract and agreement between an individual driver and Parent(s). There is no employment relation between the drivers and Morningstar Learning Center. In turn, Morningstar, its owners, staff and/or volunteers are held harmless from any claim, demand or cause of action for injury to the participant(s) which arises out of or in any way connected with any

- transportation to and from Morningstar. Morningstar will not be responsible in case of accident, illness and personal property damage.
- 12. **Bounced Check Policy**--In addition to the \$12 bank charge, a \$25 will be added on to the next invoice once a payment check has been bounced.
- 13. **Morningstar's Expulsion Policy** The reasons for expulsion and its procedures for such as a decision are explained in the **Morningstar Parent Handbook.** Reasons are but not limited to: past due tuition, unmanageable behavior of the child(ren), excessive late pick-up, refusal to complete required forms, or behavior exhibited by a parent or guardian interpreted by Morningstar as harassment to staff or other patrons.
- 14. **Non--Discrimination Clause --** Morningstar admits children regardless of religion, color, race, national/ethic origin.
- 15. **Changes in Policy**-Morningstar keeps the right to change its policies. Any changes will be notified 30 days in advance of its applicable date.
